You will be advised at the time of booking. Once you have booked and confirmation has been dispatched, the price of the holiday is guaranteed.

BALANCE PAYMENT

The balance payment is due 60 days before your date of arrival. For last minute rentals, the total rental amount is payable in full at the time of booking.

CHANGES

Should you need to make changes to your rental once the booking is confirmed, we will do our best to accommodate you. However, any amendments may result in an amendment fee, and or cancellation charges being incurred.

CANCELLATIONS

All cancellations must be made in writing and will be subject to the below listed charges. If the client does not pay the balance at the prescribed time, we reserve the right to cancel the booking.
